## Act now to establish interoperability by the compliance deadline

The final miles one of the DSCSA implementation timeline mandates the implementation of an **electronic**, **interoperable system** to trace prescription drug products at the package level by **November 27**, **2023**. The FDA refers to these mandates as the **Enhanced Drug Distribution Security Requirements** and they impact the entire pharmaceutical supply chain ecosystem: manufacturers, distributors, dispensers, repackagers, 3PLs and their trading partners. In order to satisfy the DSCSA regulatory requirements manufacturers must:

- Establish the interoperable data connections to exchange the EPCIS TI/TS information with their trading partners
- Verify that those trading partners are authorized
- Provide record keeping and access to the data for six years
- Provide all necessary facilities to expedite the response during product investigations using verification and t acing processes.
